The Company provides the necessary resources to ensure the safe and efficient operation of all Company vessels. In addition, the Company invests in modification and design improvements to further reduce the risk of incidents. This policy will be reviewed annually and is available to all employees and persons working for or on behalf of the Company and any other interested parties.
